Terms and Conditions

Reservations & Payments

A Euro €500.00 NON-Refundable and NON-Transferable deposit is required to reserve your space.

The deposit will confirm your reservation. Final balance is due no later than August 18, 2026.

***If the balance is not paid in full by the due date, we will regard the booking as cancelled**.*

Payment plans are available after receiving your deposit payment.

You will receive a confirmation email after receiving your deposit with more details about final payment arrangements.

In the case of late bookings, full payment will be required upon registration.

Retreat-Package Prices DO NOT include:

- Airfare.
- Personal order gratuities (liquor bar, special services, etc.).
- Items of a personal nature (i.e. drinks, telephone calls, personal clothing, sunscreen, elective activities).
- Emergency evacuation.
- Personal travel insurance.
- Any item that is not specified as being included.

All Retreat-Package Prices include the following:

- All regular program activities, lectures, workshops and classes.
- 7 nights accommodation in shared or single apartments.
- Delicious lunch, dinner and some snacks.
- 1-2 Group Excursion.
- Ground Transportation to and from Las Palmas Airport on arrival day (afternoon) and departure day (morning/afternoon) only. All other arrival and transfer days will be at your expense.

Sharing Accommodations:

Sharing accommodations is a great way keep costs low, as well as an incredible opportunity to get to know other amazing participants. If you have someone you have decided to share accommodation with, it is your responsibility to send us the name of your friend. Your shared apartment accommodation will not be confirmed until both individual's deposits have been received.

Cancellation by you:

You (or any member of your party) may cancel your holiday at any time providing that the cancellation is made by the person who made the booking and is communicated to us in writing. Cancellation will take effect the day such notification is received by us. If you fail to pay your deposit or balance by the due date then your holiday will be automatically cancelled and the following charges will apply. As cancellation incurs administrative costs, we will retain your deposit and, in addition, may apply cancellation charges up to the maximum shown below:

Cancellations Charge:

- 30 days or more before retreat start: Deposit only.
- 15-29 days before arrival: 75% of retreat cost.
- Less than 15 days before retreat start: 100% of retreat cost.

Once your holiday has commenced, no refund or part refund or unused portion of your retreat will be repaid in the event of cancellation by you. If the reason for cancellation is covered under the terms of an Insurance Policy, you may be able to reclaim these charges. Under no circumstances will we be able to refund the cost of your flights or other travel arrangements.
